J. Murphy noted that an updated version of the Renewable Energy Technology Degree was emailed to the Committee today prior to this meeting. RHT 102 OR SPE 101 is now listed as an option, as both courses were required previously. Some Business courses were moved to program electives. F.

Figg added notes regarding scheduling of courses. Further discussion can occur regarding listing a Scheduling Note into other programs if we find to be beneficial. Program Elective credits went from 6 to 4. Humanities/Fine Arts gen-ed was added to Semester Four. F. Figg apologized for the late changes submitted stating that the changes were made to give students more flexibility. Paid internship was added to the Summer semester. Changes made were based on advisory committee recommendation and Instructors' feedback.

J. Murphy stated that ECE 146 has been revised from 2 credits/2 lecture to 3 credits/3 lecture, with added topics. The change in credits for ECE 146 effects the above programs, which prompted revisions. A. Miller added that the additional hour was added to ECE 146 to cover the DEI topics and outcomes and will make the class more transferable. ECE 146 will also be submitted to the IAI for approval, which is another reason the course was revised to 3 credit hours, per IAI's requirement.

J. Murphy stated the new Barber Certificate includes 6 reactivated courses and 1 new course, with a total of 50 program credits. F. Ghauri added that the reactivated courses were active and withdrawn in 2010 and are now being reactivated and all are added as electives to the Pre-Engineering program. Students will be able to utilize these courses when transferring to Engineering programs at four-year universities, as we will be seeking IAI approval. Engineering Physics is a prerequisite for all EGR courses. The EGR courses, with the exception of EGR 195, will be submitted to the IAI for approval. These courses will also benefit students enrolled in the Associate in Sciences program and 2 + 2 Engineering Degrees. J. Murphy stated that F. Ghauri had worked with A. Sharris to keep ENT 110, that is currently being revised and will also seek IAI approval. M. Flaherty asked if these courses are geared toward any specific engineering degree. F. Ghauri replied that Physics I and Physics II are foundation courses for all Engineering programs, i.e. Electrical, Mechanical, etc. Can go with available options. They have a matrix to follow. M. Flaherty added that we should still look at where they transfer and the elective they want. J. Murphy asked if a 2 + 2 is already confirmed. F. Ghauri replied that once approved he will set up a 2 + 2 with the four-year schools. J. Murphy question which school students transfer to for Engineering. F. Ghauri responded that he has spoken to UIC and IIT. U of I require students to take courses in their order and are very restrictive. A. Sharris added that after working with Engineering and Engineering Technology programs, the courses in Pre-Engineering component will assist the students to enroll into four-year Engineering programs The IAI component is strictly for UIUC. We are also looking at developing a 2 + 3 agreement in the future. J. Murphy said that is great that the Engineering students will have a path to follow.

***M. Flaherty made a motion, seconded by W. Griffin, to approve item numbers 23-18 through 23-25, passed unanimously with a virtual vote, by a show of hands.***
